# **Emilio R. Ypiñia Journals**

This collection consists of five distinct journals authored by Emilio R. Ypiñia (1905-1936). A self-educated Mexican national born in Aguascalientes, Aguascalientes, Mexico, Ypiñia immigrated to Houston, Texas, following the Mexican Revolution of 1910. Each volume contains approximately 100 pages and 10-20 poems, essays, and journal entries, the bulk in 1933.

# The Astrodome, Eighth Wonder of the World


The world's first indoor, air-conditioned sports stadium, the Houston Astrodome was nicknamed the "Eighth Wonder of the World" when it opened in 1965. The construction of the Astrodome was instrumental in bringing Major League Baseball to Houston, and the Dome would also host the NFL's Houston Oilers and the Houston Livestock Show and Rodeo. A selection of over 100 items, including promotional photographs, newsletters and brochures, and documents on the creation of the Astrodome, illustrates the history of the stadium and the key individuals who brought this vision to life.

# Carlos (DJ Styles) Garza Drawings and Memorabilia

Enter the world of Carlos "DI Styles" Garza, who has in turn been a high school b-boy and aspiring graffiti artist, an up and coming club DJ, producer for the highly creative hip hop artists Odd Squad and Devin the Dude, and an independent producer and audio engineer. This digital collection contains approximately 50 artworks, sketches, fliers, and promotional items from the eighties to the 2000s, related to Garza's life in hip hop.

# **Board of Regents Records**

This collection includes the minutes from the meetings of the Board of Trustees between 1939 and 1944, and later, the Board of Regents, the governing body of the University of Houston system. The meeting minutes provide insights into the evolution and governance of the University. Digitization of these records is ongoing, and subsequent volumes will be added to the UH Digital Library as they become available.

Jack S. Reaves 1950s original archive of manuscript letters detailing the ups and downs and final success of a Texas wildcat oil prospector = \$4500. Reaves, a Floridian, came to Midland, TX, in 1958 to make his fortune in oil. This archive of 65 handwritten letters to his wife Dorothea back in Florida journals his efforts and eventual success: "IT BLEW AND BLEW AND BLEW!!!" Also includes a scrapbook of his proposal to investors, news clippings, and photographs taken at the oil well site.

Juegos y Diversiones de Posada by Mercurio Lopez Casillas, 1st ed., published by Ediciones Acapulco, 2013 = \$500. In celebration of the 100 year anniversary of the death of the famous Mexican artist and illustrator Jose Guadalupe Posada, this collection reproduces various board games illustrated by Posada, including Loteria, Corrida de Toros, and Juego de la Oca, and includes a book that discusses the history of the games.

Travels Into Several Remote Nations of the World (Gulliver's Travels) by Jonathan Swift, printed for Benj. Motte, London, 1726 = \$7,000. Teerink's "B" first edition of the most famous satire in the English language and a staple for teaching at the University, Gulliver's Travels satirizes government, religion, colonialism, and science.

The Birds of America from Drawings Made in the United States and Their Territories by John James Audubon, published by Roe, Lockwood & Son, New York, 1840-1844 = \$65,000. First octavo edition, in 7 volumes with full morocco binding. 500 hand-colored plates after Audubon by W.E. Hitchcock, R. Trembley, and others. One of America's most important and beautiful natural history books.

Americae pars quarta, sive, Insignis & admiranda historia de reperta primùm Occidentalis India à Christophoro Columbo anno M. CCCCXCII by Theodor de Bry, 1st ed., published in Frankfurt, 1590-1594 = \$450,000. Set of 12 of the original 13 by the famous engraver and documenter of European expeditions to the Americas. The University currently owns one volume that is frequently used for teaching about European colonial settlement in the New World and the interactions between Europeans and Native Americans.

# DONORPROFILE J ack Hall, cataloging librarian at the University of Houston Libraries, has established an endowment supporting international travel for UH librarians. Hall dates his interest in librarianship

The endowment will provide assistance to UH librarians for expenses associated with international travel. Librarians are increasingly pursuing professional development and scholarly activities on a global scale, attending conferences and sharing expertise on a number of topics in information science.

Hall has been a UH librarian since 1976, primarily in cataloging. He was also a reference librarian, and the subject librarian for English and linguistics for nearly 20 years. He was inspired to establish the international travel endowment based on his own experiences as a scholar and librarian.

"After studying and teaching linguistics and Germanic languages for several years, I decided to transfer my academic interests to librarianship," Hall said. "I was active in the American Library Association, attending conferences and serving on and chairing a number of committees and interest groups."

Hall spent two years studying abroad in Germany, 1964-1965, on a Fulbright Fellowship, and 1967-1968, on a Danforth Fellowship. He has always felt that these experiences have been fundamental to his academic and intellectual life and work as a librarian. He strongly encourages work and experience abroad as an extension of any librarian's career.


his interest in librarianship as far back as his childhood when he regularly used the county-library-supplied Bookmobile in his small home town of Damascus, Virginia, which had no library. The librarian who accompanied the Bookmobile recognized Hall's maturity and interest in books and began recommending materials more advanced than a child might have otherwise encountered, greatly facilitating his education and intellectual development.

Hall is a Phi Beta Kappa cum laude graduate of Davidson College (1964) and has master's degrees in Linguistics from Princeton University (1967) and in Library and Information Science from the University of Pittsburgh (1976). He was a member of the University of Virginia German Department and Linguistics Program faculty from 1970 to 1973. Hall joined the UH Libraries as a cataloging librarian on October 15, 1976.

After retiring in 2013, Hall continues to work parttime as a music cataloger. The length of his career at UH and his eagerness to continue working in the Libraries demonstrate the extent to which he values the Libraries and his colleagues.
